Treaty 8 Annuity Settlement Community Update

What's happened so far...

- Information sessions on the Settlement Agreement and Trust Agreement took place in-person on January 17, 2026 and online on January 21, 2026.
- Electronic voting was open from February 9th, 2026 to February 13th, 2026 and in-person voting occurred on February 13, 2026.
 - **Result:** 1200 members voted in favor; 45 members voted against.
- Chief and Council have signed both the Settlement Agreement and Trust Agreement.

Next Steps

- Canada is expected to sign the Settlement Agreement in **Spring 2026**, with payment to the Trust occurring within **45 days** after signing.
- Beginning **March 2026**, DCN staff will start compiling a list of all individuals entitled to a PCD ("Eligible Persons") as applications are received.
 - **This step is solely to gather and update information ahead of time, so that all required details are prepared in advance for when annuity payments are ready to be issued.**
- ***This is exclusively to DCN members who are 18 years of age or older. Individuals under 18 may apply once they reach the age of majority.***
